DON'T GO IN THE CELLULAR!

Well, AT&T is about done with its fiber optic project. Or so it says. THE LONG AND WINDING ROAD

Our boy reporter Tintin was busy on another story (something about a Pharoah and a cigar), so we asked back-up reporter Jimmy Olsen to look into what is or is not going on with respect to the non-work on the Moorpark Freeway, aka “The 23.” He first tried going straight to the source, but between CalTrans and the local vendor doing the work and their respective websites, little information was to be found beyond how to donate to their pension funds. (Apparently CalTrans has some sort of birdcall resource called “Tweeter” on which it provides info, but our homey Jimmy don’t play dat.) So Jimmy turned to some actual workers on the project. When asked what was going on, they first said, “Lunch.” When asked what was after lunch, they said, “Dinner.” Undaunted, he then asked what would happen in between, and fought through the initial “not much” answer to learn that between meals, well, not much gets done.

COMMUNITY RULE OF THE MONTH

Please be reminded that our neighborhood rules and regs prohibit motor homes, trailers, boats, and similar oversized vehicles from being parked outside your garage, let alone lived-in:

5. Any oversized non-primary vehicles such as commercial-type V vehicles (i.e., dump trucks, cement mixer trucks, oil or gas trucks, delivery trucks), camper units, motor homes, buses, trailers, trailer coaches, camp trailers, boats, aircraft, mobile homes or any other similar vehicle or vehicular equipment and inoperable vehicles are considered Prohibited Vehicles. Prohibited Vehicles must be parked in the garage or stored off premises.

...

9. No trailer, camper, motor home, or recreational vehicle shall be used as a residence in the properties, either temporarily or permanently.

Why this rule, you ask? Well, have you ever seen “National Lampoon’s Christmas Vacation”? ‘Nuff said. Yes, we know *your* RV is super clean and the whole neighborhood is welcome to watch a movie with you on its outdoor big screen with speakers that can be heard at the Sunset Hills Country Club. *Thank you.* But if we can’t let Randy Quaid in with his roach motel on wheels, we can’t make exceptions no matter how nice *your* trailer is. Garage it or store it, please.

OBEY SMOKEY THE SHOWSCAPES BEAR

As previously reported, your HOA Board has been proactive about fire prevention in the wake of the devastating Woolsey Fire that thankfully only threatened our community. In the aftermath of that conflagration that came too close to Woodridge for comfort, the Board saw to the completion of 5 years worth of preventive brush removal required by new state and local laws in less than 2 years. A downside to fire prevention in the open space around Woodridge is the loss of some foliage—as just one example, the Fire Marshal required removal of extensive areas of well-established acacia on slopes adjacent to many homes. Other homeowners have lost a view of some trees farther up their sightlines to our surrounding open space—these trees all have been removed by order of the Fire Marshal, with whom Board members have walked the entire community on several occasions since the new fire prevention rules went into effect. Occasionally some of those trees or their hitherto buried offshoots have attempted a comeback, but our landscaping crew keeps an eye out and continues to remove new growth in compliance with the Fire Marshal’s direction.

Friends, **please remember** that the community's hardworking landscaping crew is responsible to the HOA Board, not to individual homeowners. Some undoubtedly well-meaning homeowners occasionally have asked the crew to stop tree and brush clearing efforts in the understandable hope of saving a part of their own view, but this comes at the risk of increased fire danger to the entire development and a rebuke or even a fine at our next Fire Marshal inspection. Our landscapers have been instructed that **no homeowner has the authority to direct their activity** because, well, none of us does have such authority. That is in the Board's bailiwick.

PAGING MARSHAL DILLON

Ventura County is going to have a competitive race for Sheriff for the first time since 2010 (he recently has run unopposed). Commander Fryhoff, who recently was reassigned by Sheriff Ayub to the county jail system after serving about a year as Thousand Oaks Police Chief (TO contracts with the Ventura County Sheriff to supply policing, hence those dual references on all the patrol vehicles you don't see until too late), is running against Ayub in an election to be held in *June of 2022*. Neither has commented about the recent reassignment's impact on Fryhoff's decision to run, but Fryhoff has said he was "blindsided" by his transfer. (Ooooh, intrigue in the TO!) In any case, it is an important local race that deserves our attention. Police chiefs are appointed, but sheriffs are elected, and the VC Sheriff has a big impact on Thousand Oaks because he appoints our local police chief.

Those Thousand Oaks Acorn newspapers distributed in our community for free each week can be counted on to follow the race like night follows day, and the Letters section will be filled with

contrasting opinions of our neighbors weighted proportionally to total letters received on one side or the other. Some letter writers actually may know what they are talking about, so the Acorn is a great way to keep up with the race and to make an informed decision when the time comes for you to vote (or to give your ballot to that nice person who says s/he/it will take care of depositing your ballot for you).

While on the topic of the Sheriff and our local constabulary, please remember that the TO PoPo are keeping a close eye out for speeding on Erbes Road, especially between Sunset Hills and Avenue de los Arboles. It is what the local gendarmes call a “ticket rich environment.” (If you can get used to slowing down a little there, maybe you also can slow down a little bit inside our gates? You don’t want to see more stop signs installed, am I right?)

HAPPY TRAILS TO YOU

Our adventure reporter Matt Erhorn and his better half Kat Mandoo would like everyone to stop, hey, and look what’s goin’ down on our myriad local hiking trails. New to the area, Matt and Kat recently explored Sapwi Community Park, which has entrances and parking off Erbes Road to the west, Avenue de los Arboles to the north, and Westlake Boulevard to the east. At the parking lot on Erbes Road across from Los Cerritos Middle School you will find a large playground for the kids with lots of climbing equipment, a small “skate park” area for the littler ones, and even a disk golf “putting green.” At the far eastern end of that playground is a trail leading down to a wooden bridge across Lang Creek with informative signage about local flora and fauna. Continue on the dirt trail east along the creek through the back 9 of an enormous disc golf course (most holes are up the hill to the south of the trail) and eventually you will arrive at an enormous bike park with humps and bumps and jumps marked for all skill levels (and a place to watch the action without auditioning for an episode of “Ridiculousness”). Up the hill to the east of the bike park is the Westlake Boulevard parking lot, and the trail takes you from there back down to the creekbed and a few of the front 9 disc golf holes.

This is a spectacular community resource—and amazingly, not particularly busy. Matt and Kat highly recommend the whole trail—from Erbes Road to Westlake Boulevard and back again is about an hour hike at a decent pace, and opportunities to climb some adjacent hills for extra cardio abound.

OLD BUSINESS

Quick reminders of past newsletter topics (prior newsletters are posted on the website at www.woodridgeestatesresident.com):

-Community resident vehicles bearing an RIFD transponder on the headlight to open the front gate will receive a citation and ultimately a fine if parked on community streets between 7 pm and 7 am. Vehicles lacking an RIFD but visibly bearing a gate-issued guest pass on the

dashboard may park on the street anytime, so please make sure your guests receive and display such a pass.

If you get a new car, get a *new transponder* for front gate entry *when you get your new permanent plates*. Contact Imellini@pmpmanage.com. Until then, use the visitor entrance and get to know our gatekeeper crew.

-Please don't feed the local fauna. It encourages the rats, who love your car wires. (Another good reason to clean out and park in your "garage," which by definition is "a building for housing a motor vehicle or vehicles," not "a building for storing stuff you don't remember you have."

-Our suspicion that some miscreant from Eagle Ridge is responsible for bagging Princess Poochie's poo and then just leaving the bag on the ground has obtained new credence—a similar who-doo was observed by our resident hiker Matt Erhorn while on a trek near Sapwi Community Park off of Avenue de los Arboles (Eagle Ridge is right around the corner—*ha!*). -Homeowners are responsible for their own "medians," i.e., the planting area between the street curb and the sidewalk in front of your home. If your median is looking dry, you may need to break out the hose or even some dirt and grass seed to help keep our community streetscape looking fresh—it is part of the curb appeal that brought you here, remember? If you have a question about whether a median is yours (usually) or part of the common area (not so common), please send a note to Mr. Mellini at PMP Management for clarification--caring for your front yard and your median is part of every homeowner's duty to your neighbors.

-A big shout-out to HOA President Mary Jo Ammon for collecting the funds necessary to get a "Stop Ahead" warning sign replaced on Sunset Hills near Woodworth from the driving school reject who ran it over from the opposite side of the street, no less. That sign is now back in action! The Board also is working on replacing a mailbox damaged by an Amazon vehicle on Heavenly Ridge—Amazon is expected to pay, but the problem is finding a supplier for the same kind of mailbox originally purchased 21 years ago. The HOA Board is on the case! Mary Jo also is diligently trying to collect from the front gate flower pot haters who broke them.
