COMMITTEE UPDATES

Rules/Regulations & Safety:

The committee has presented a revised draft of the Rules and Regulations and it is in review with the Board. Further discussion regarding this matter will take place during the Board meeting. The committee is also recommending fencing of additional areas and reinforcing existing fencing of our perimeter, along with signage regarding our private property.

Finance:

- All HOA funds (cash) is covered by FDIC insurance either in TIAA CDARs or under Mutual of Omaha Bank.
- Capital projects under consideration: enhanced fire abatement, reinforcing perimeter fencing, installing additional perimeter fencing, slope maintenance and painting of the mailbox posts.
- Consideration of a special assessment.
- We are in the process of working on the Budget for fiscal year 2020 and reviewing an increase of monthly dues by \$5, \$10 or \$15 per month.

Landscaping:

The Landscaping Committee presented to the Board a long term plan to address tree, root and pavement issues in our community. They are working with the City to get permits, contractors to secure bids, as well as arborists and other professionals. The initial plan involves “replacing 19 trees, removing 16 Oaks, pruning 2 Oaks and replacing 15 pavement areas”. The fees to get the project going have been approved. Arborist James Dean has been selected to assist with this project.

The Board will proceed with enhanced Wildfire Prevention that will bring the Association in compliance with the new Ventura County Fire Protection Ordinance. This will cover the North, South, East and West Property line Slopes.
